

Report from Your District Councillors for Napton Parish Council – August 2025

Local Government Review

All of Warwickshire's District and Borough Councils along with Warwickshire County Council would be affected by the plans suggested in the [English Devolution White Paper](#), which is the Government's statement of its intention to reform local government.

On Monday 14 July, the full Council identified their preferred option at this stage as two unitary Councils for Warwickshire.

The District Council was being asked to determine which option under local government reform is its preference. To assist them, the District Council has considered a report by audit and assurance specialists, Deloitte, which was carried out on behalf of Stratford-on-Avon District Council alongside the other Warwickshire District and Borough Councils. This includes a wide range of proposals on devolution, but also wider plans for Local Government Reorganisation.

The [Deloitte report](#) (click the link – it is online on SDC's website) evaluates the two proposals which were identified by Council in the "interim plan" in March, these being:

- Option 1 - Single unitary model: A single unitary council based on the existing geography of the five Borough and District Councils and the County Council.
- Option 2 - Two-unitary model: A two-unitary council model as follows:
 - (1) Based on the existing boundaries of North Warwickshire Borough Council, Nuneaton and Bedworth Borough Council, Rugby Borough Council, and part of Warwickshire County Council
 - (2) Based on the existing boundaries of Stratford-on-Avon District Council and Warwick District Council and part of Warwickshire County Council.

These have been evaluated against the 6 criteria to be used by government in determining future structures and the report concludes that a two-unitary model emerges as the most advantageous structure for Warwickshire.

The matter will be the subject of further public engagement so that residents are able to express their views, prior to the final submission to government on 28 November. It is important that the public consultation is objective and on the basis of a well informed background. The District Councils combined will be launching such a consultation in the next few days, which will be circulated to parish councils. Five Year Housing Land Supply

Stratford-on-Avon District Council has released an interim update to its Five-Year Housing Land Supply (5YHLS) position, reflecting recent changes to national planning policy and a significant increase in Local Housing Need (LHN). Having a Five-Year Housing Land Supply is key to maintaining proper management of development across the District.

Following the Government's revision of the National Planning Policy Framework (NPPF) and an updated methodology for calculating LHN introduced late last year, the District Council's annual housing requirement has risen from 730 to 1,126 homes per annum.

In response, the District Council has reassessed its housing land supply assumptions, particularly regarding delivery expectations from key sites.

Despite these adjustments, and some challenges from developers, the District Council believes that it continues to demonstrate a five-year housing land supply, with the updated position showing a supply equivalent to 5.06 years. This ensures that the adopted Core Strategy retains full weight in the determination of planning applications.

Health Screening Events – a reminder!

Stratford on Avon District Council has joined together with the Graham Fulford Charitable Trust to offer a series of health screening events for both men and women across the District.

The tests on offer cost £14 each, subsidised by the District Council and are:

- For men over 40 – PSA (Prostate screening)
- For men and women aged 18 and over – diabetes and cholesterol

A series of events have been held across the District including one at Southam in July. Events run from 10am to 2pm and the next one is on Saturday 13 September at Stratford Leisure Centre.

HS2

There will be A423 closures between Ladbroke and Southam during September and November. This relates to the construction of the bridge there and the connection to the road. The disruption whilst regrettable, is less bad than it might have been due to the intervention of councillors and council officers in putting pressure on HS2 and the contractors who intended much longer closures. In detail the estimated timings are:

- Early September 2025 - Two-week road closure to join the bypass to the current road. Operation of bypass around north bridge approach road. 30mph speed limit in place.
- November 2025 TBC -Weekend road closure to install safety barriers in the road on the south approach road, by layby to continue construction safely
- Summer 2026 - Three-to-four-week road closure for permanent tie-ins of new bridge

- We are told that other ‘occasional’ weekend closures or traffic management may be required.

The long-scheduled closure of the road between the Fenny Compton Wharf and Priors Hardwick is still due for ‘late summer’ and will last for up to two years. This will be preceded by a short-term closure of the same section for 2 weeks starting on 5 August.

Severn Trent

Nigel continues to be in contact with senior staff at Severn Trent about the supply side works in the parish. The timetable seems to drift and Nigel has suggested that ST should come to the village and repeat the presentation that they made in January 2023 on the same subject, and explain progress. Meanwhile several environment groups including our own NEAT, have been pursuing the issue of foul discharges both here and across the wider area, and some sort of information meeting is due shortly.

Meeting with the Police and Crime Commissioner

Nigel and Natalie have met with the Police and Crime Commissioner to discuss ongoing ward concerns. The Commissioner wished to reassure residents that uniformed officers are not the only police officers and around half of the police force are not in uniform. Nevertheless, the Commissioner did acknowledge that Southam SNT are a small team working in a large geographical area and he would take our points to his weekly discussion with the Chief Constable.

The Council may be aware of some incidents locally with a group of travellers who camped on private land sequentially, in Harbury, Bishops Itchington and Napton, before leaving the area. Nigel has been in discussion with the police and the District Council ASB team about the incidents and any learning points that might arise.

Community Safety

Stratford-on-Avon District Council's CCTV system has received the British Standard Accreditation which recognises good management and practice for an eighteenth consecutive year.

Accreditation under British Standard 7958 follows a comprehensive assessment based on 120 separate criteria, with no recommendations made following the audit. The District Council's CCTV is operated in partnership with local towns and parishes.

Community Climate Change Fund

Round Three remains open for applications. There is no deadline as applications will be assessed on a quarterly basis, meaning applicants will have to wait a minimum of three months to be informed as to whether they have been successful or not. Hospital parking

Anyone who has tried to visit either Warwick or Stratford hospital lately will have found great difficulty in parking, with little alternative travel options. Nigel has put forward a motion to council as follows:

‘Council welcomes the current improvements being made to Warwick and Stratford Hospital facilities but notes that the associated building works are having detrimental effects on parking and access for patients and visitors. Difficulty with parking was already an issue prior to these works beginning. These hospitals provide services over a wide area of South Warwickshire and for most residents of Stratford District, transport is substantially reliant on the use of the private car. For many council wards there is no public transport available in any form. Whilst the hospital authorities presently warn of likely difficulties with parking when attending the hospital, they provide no information or promote the use of such limited public transport that is available. Apart from inconvenience and worry for the public there are impacts on the environment, traffic, NHS staff, missed appointments and thus NHS efficiency.

Council calls on Cabinet to establish an initiative to work with the hospital and health authorities, the County Council, Warwick District Council and voluntary bodies to seek an improvement in transport solutions for residents’ attendance at our local hospitals. Elements might include dial a ride, information system, advertising, mobile phone apps, park and ride, interaction with operators, extension and support to voluntary driver schemes, improvements to time tabling and support for extra services. ‘

Postal Voters

Following changes introduced by the Elections Act 2022, voters are now required to reapply for their postal vote every three years. All postal voters who completed a postal vote application form before 31 October 2023 will be required to renew their postal vote application by 31 January 2026. Postal votes will be limited to a maximum of three years, following which it will be necessary to make a new application.

Stratford-on-Avon District Council will be contacting around 17,000 registered postal voters in the District directly by email, where an email address is held or by post informing them of the new rules and encouraging them to reapply as soon as possible ahead of the deadline. If voters do not reapply before the deadline, their postal vote will be cancelled.
