### Item 15 - Community Governance Review (Informal Consultation)

- This agenda item gives Napton Parish Council the opportunity to decide whether it
  wants to take part in a proposed partial Community Governance Review being
  considered by SDC.
  - The review is part of wider discussions about potential changes to local government in Warwickshire, including the possibility of creating a **new unitary authority** (which would replace the existing two-tier structure of district and county councils). If this goes ahead, new governance arrangements and elections would likely take place in **2027**.
  - SDC is currently gathering expressions of interest from eligible parish councils who may want to look at their own arrangements — for example, changes to the number of councillors, whether to group or separate parishes, or changes to parish boundaries (although some of these changes may be deferred until a new authority is created).
  - The informal consultation is open until 11 July 2025, and the Parish Council
    needs to decide whether it wishes to express interest in reviewing or changing
    anything about how it currently operates even if just to explore the options.

#### Item 17 - Allotments

- Document attached The document outlines allotment plot sizes, classifications
  (Small, Medium, Large), and their corresponding rent and deposit fees. It includes a full
  list of plot dimensions, associated costs, and size-based rent/deposit thresholds.
  Additional notes highlight specific issues, such as overgrown plots, ash tree concerns
  (possible dieback), and plots that may be suitable for splitting. It also provides
  estimated totals for rental income and deposits if all plots are occupied.
- Ash tree suspected of Ash Dieback Has been surveyed by Richard O'Shea. An initial assessment of the Ash tree suggests its overall canopy health is fair, with minimal signs of Ash dieback. Some defoliation in the upper crown is likely due to caterpillar activity in May/June. The recent branch failure does not appear to be due to poor tree health but may be the result of a defect or wind damage. It is recommended that the fallen branch be cleared to allow a more thorough inspection of the tree base, after which it can be added to the tree inventory.
